Discussion held on purchasing a maintenance truck from City of Carson. Motion by Goos that Swope bid on City of Carson's maintenance truck, 2<sup>nd</sup> by Emge- 4 ayes.

Motion by Goos to Adopt Resolution 2022-5 FY22-23 Pottawattamie County Law Enforcement Contract, 2<sup>nd</sup> by Emge. Roll Call-Ayes: Swope, Goos, Duede, Emge. Motion Carried.

Motion by Goos to set Public Hearing for FY21-22 City Budget Amendment on May 10, 2022 at 7:00 pm, 2<sup>nd</sup> by Swope-4 ayes.

Maintenance Report given by William Johnson.

Motion by Duede to purchase playground mulch from Maple 85 Premium Landscaping, 2<sup>nd</sup> by Goos- 4 ayes.

Discussion held on ball field maintenance and patching streets.
