Motion by Swope to accept Dan Claar's bid to spray the weeds around the large lagoon in the amount of \$900 with proof of insurance, 2nd by J. Keast- 5 ayes.

Motion by J. Keast to accept Cuenca Coatings bid to fill 23 potholes for \$140.00 per pothole. Potholes must be cleaned and oiled prior to filling, 2nd by T. Keast- 5 ayes.

Motion by J. Keast to hire a contractor to repair the tractor playground equipment in the park that was damaged by a fallen tree, 2nd by Croson- 5 ayes.

Motion by J. Keast to seek bids to trim 3 trees in the City Park, 2nd by Swope- 5 ayes.

Skip Raney volunteered to repair the bench in the Main Street Gazebo Park. Motion by J. Keast for the City to purchase material for the bench, 2nd by Duede- 5 ayes.

Motion by Croson to order new water meters and cables, including a meter for the DeWitt Community Center, 2nd by T. Keast- 5 ayes.

Emge provided a water/sewer report.

Antunez provided a maintenance report.
