Mayor Clark called the Regular Council meeting to order at 7:00 pm. Pledge of Allegiance.

Matt Mills presented a MTS Inc for 5 year renewal contract, raising garbage rates to \$15.60 and 2nd trash can rates raised to \$8.00 per extra can, additional rate increase of \$1.50 to be added again after two years. Curb side recycling will no longer be available, blue containers can be returned to City Hall. A new contract will be drawn up and approved at the April council meeting.

Brien McCready presented a proposal to the city to purchase land and a section of street on 402 Evans St. The garage has a shared street with the Macedonia Community Church. Gary Forristall, Dave and Mary Pumphrey spoke on behalf of the church. An updated proposal will be presented at the April Council Meeting.

Motion by T. Keast to approve 1st reading to amend water rates Ordinance 181, 2nd by Croson – Roll Call: Ayes: Swope, Croson, J. Keast, Duede, T. Keast. Motion Carried.

Motion by Swope to Set Public Hearing for April 22nd 2025, at 7p.m. for Budget 2025-2026, 2nd by T Keast - All ayes.

Motion by J Keast to approve Event Lease Agreement for Dawn Thompson of Cloud Wine LLC dba Lucky Wife Wine Slushies to park on Potter Street on August 15 & 16 for Donia Days, 2nd by Swope - All ayes.

Motion by J Keast to approve Resolution 2025-6 Setting Wages and Benefits for Maintenance Operator, 2nd by Croson. Roll Call- Ayes: Swope, Croson, J Keast, Duede, T Keast. Motion Carried.

Council discussed replacing city handicap signs on Main Street at the Bank and City Hall. City Clerk will contact the DOT to replace city sign on Hwy 92, also contacting owner of 306 Woodmancy regarding abandoned trailer.
