



Pottawattamie County Special Election August 1, 2023

Pottawattamie County will be conducting a Special Election on Tuesday, August 1, to allow the voters in the County to determine if the individual members of the Board of Supervisors in Pottawattamie County shall be elected by one of three plans described as follows:

- Plan "One". At large and without district residence requirement for the members.
- Plan "Two". At large but with equal-population district residence requirements for the members.
- Plan "Three". From single-member equal-population districts in which the electors of each district shall elect one member who must reside in that district. Currently, Plan "One" is how Pottawattamie County Supervisors are elected. After the polls close on August 1, the plan receiving the most votes will be the method used to elect the individual members of the Board of Supervisors in 2024.

If Plan "One" receives the most votes, no changes will be made.

If Plans "Two" or "Three" receive the most votes, the County will be apportioned into single-member supervisor districts on the basis of population pursuant to specific requirements as directed by Iowa Code Section 49.3 Election precincts and districts. A temporary county redistricting commission will be appointed to identify the district boundaries after the August 1 special election.

All election districts, including county supervisor districts, shall be drawn according to the following standards:

- a. All boundaries shall follow precinct boundaries;
- b. All districts shall be as nearly equal as practicable to the ideal population for the districts as determined by dividing the number of districts to be established into the population of the county. According to the 2020 U.S. Census Bureau, the population of Pottawattamie County is 93,667. 93,667 divided by 5 = 18,734 (Ideal population)
- c. All districts shall be composed of contiguous territory as compact as practicable.
- d. Consideration shall not be given to the addresses of incumbent officeholders, political affiliations of registered voters, previous election results, or demographic information other than population head counts, except as required by the Constitution and the laws of the United States.
- e. Cities shall not be divided into two or more county supervisor districts unless the population of the city is greater than the ideal size of a district. Cities shall be divided into the smallest number of county supervisor districts possible. The population of Council Bluffs is 62,415, greater than the ideal size of a district (18,734).

Dates to remember:

- You may request an Absentee ballot now. They will be mailed on July 12th.
- In person voting at the Pottawattamie County Courthouse begins on July 12th.
- Voting at your assigned Precinct will be on Tuesday, August 1, from 7 a.m. until 8 p.m.

CITY OF MACEDONIA - PUBLIC NOTICE - RESOLUTION 2023-8 CITY OF MACEDONIA WATER CONSERVATION DECLARATION EFFECTIVE 6/13/2023

BE IT RESOLVED by the City Council of the City of Macedonia, Iowa:

That we do hereby declare a Public Water Conservation: Water Warning Level 2 as defined Per City Code Chapter 93.05 in the City of Macedonia, Iowa during which time the following measures and provisions of City Code of Ordinances Chapter 93 Water Conservation shall be in effect to produce an orderly and equitable reduction of water consumption until, by resolution, the Council finds and declares the water shortage condition to be ended.

BE IT FURTHER RESOLVED that the City Clerk is directed to publish and post this resolution to inform the public of the measures and provisions of City Ordinance Chapter 93 Water Conservation.

Passed and Approved this 13th Day of June, 2023.

To review Macedonia City Code Chapter 93 Water Conservation in its entirety please contact or visit the City Clerk's office at 322 Main Street, Macedonia, IA. City Hall Phone 712-486-2323. Excerpts of City Code Chapter 93 Water Conservation are as follows:

93.02 CONDITIONS.

- 2. Water Warning. A Level 1 or Level 2 Water Warning may be declared when a water shortage or equipment failure poses a serious threat to the ability of the water system to meet the needs of its customers currently and in the foreseeable future. Indicators of the need to impose a Level 1 Water Warning include:
 - A. System operating at eighty-five percent (85%) of pumping capacity;
- B. Significant decrease in the pumping water level of wells or significant decrease in recovery rate of water level in wells;
- C. Significant decrease in reservoir levels measured in number of feet below spillway or number of feet above intake.

Indicators of the need to impose a Level 2 Water Warning include severe system emergencies such as a chemical spill or major system failure in feeder mains or treatment plant.

93.05 WATER WARNING — LEVEL 2. Under a Level 2 Water Warning, no person shall use potable processed water of the City water supply in any manner contrary to the following:

- 1. All outside water use, except for domestic, sanitation and fire, is prohibited.
- 2. All commercial and industrial uses of water not essential in providing products or services is prohibited.
- 3. Irrigation of agricultural crops is prohibited.
- 4. Recreational and leisure water use, including lawn and golf course watering and other incidental or recreational uses, is prohibited.
- 5. Water use not necessary for the preservation of life or the general welfare of the community is prohibited.
