**Regular City Council Meeting**

**November 7, 2016**

Mayor Braden called the regular council meeting to order at 7:00 PM. Council present: Swope, McCready, Wax, Dorr, Goos.

Motion by Goos to approve agenda, second by Swope - 5 ayes.

Open forum - Wong Antunez discussed street at north Clayton St being considered by Council to vacate as future street to addition of housing.

Motion by Goos to approve October 11, 2016 minutes, second by Swope - 5 ayes.

Motion by Swope to approve bills, second by Dorr - 5 ayes.

Motion by Goos to approve Clerk/Treasurer's Reports, second by Swope - 5 ayes.

Motion by Dorr to approve Utility Report, second by Wax - 5 ayes.

Motion by Goos to accept Karen Tye, Zoning Permit Chair resignation, second by Swope - 5 ayes.

Shawn Stevens will move to Chair of Zoning Permit including Wong Antunez on the Commission.

Motion by McCready to set Public Hearing for Vacating city-owned right-of-way abutting property west of 210 Brodbeck St at December 13, 2016 Council Meeting, second by Goos - 5 ayes.

Motion by Swope to adopt Resolution 2016-16 City Annual Finance Report Year Ending June 30, 2016, second by McCready. Roll call vote: Ayes- Dorr, McCready, Wax, Goos, Swope. Motion Carried.

Motion by Dorr to adopt Resolution 2016-17 Revised Agreement between City of Macedonia and Macedonia Fireman's Association, Inc., second by McCready. Roll call vote: Ayes- Dorr, McCready, Wax, Goos, Swope. Motion Carried.

Motion by Goos to request the MidAmerican donation for repairing the Merry-go-round on Main Street, second by Swope - 5 ayes.

Swope requested a reminder of the Junk Vehicle Ordinance in the December newsletter from the Council.

Motion by Goos to add Traffic Regulations Ordinance to the City Code of Ordinances with the first reading at the December 13, 2016 Council Meeting, second by Dorr - 5 ayes.

The Council discussed the Sidewalk Ordinance and a map of current sidewalk placement. The Council would like to remind the residents of the sidewalk ordinance in the December newsletter. Further review of sidewalks will be ongoing.

Motion by Swope to file petition to obtain the abandoned property at 516 Cipher Street, second by Dorr - 5 ayes.

Goos discussed the Main Street project grant application submitted to CITIES, and looking into the RPA18 state grant for streets. Goos will set up a meeting with the County Engineer.

Ransom, maintenance operator report: testing for lagoon in process to prepare for release.

Wax recommended sending a thank you to Don Tye for complying to the request of replacing the sidewalk at his property.
